## Instructions for Authors---PAPER

### Papers must necessarily be submitted in English

The paper should be formatted as follows in Microsoft®Word™ processing program:

#### **Title**

(Times New Roman Bold 14 pt. and centered)

Leave two empty lines after

**Author First Name Last Name<sup>1</sup>, Author First Name Last Name<sup>2</sup>**

(Times New Roman 12 pt. normal and centered)

1 List the name of the department, institution and full postal address (including postal code, country, phone and email) (Times New Roman 10 pt.)

2 List the name of the department, institution and full postal address (including postal code, country, phone, and email) (Times New Roman 10 pt.)

Leave two empty lines after

#### **Abstract**

(Times New Roman Bold 12 pt.)

Leave two line spaces

All margins should be set to 25 mm. Use a one column format. All text must be justified and prepared in 11 pt. Times New Roman.

Abstract should be limited to 200---250 words (Times New roman 11 pt., normal). The abstract is limited to one page

Keywords: Times New Roman 10 pt. normal

#### **Paper:**

The paper is limited to 10 pages and must be formatted in Word™.

All margins should be 25 mm. Use 12pt.**bold** lower case forma in headings.

All text must be justified and prepared in 11pt. Times New Roman.

Leave an empty line between paragraphs. All Figure sand Tables should be numbered and contain a caption(11pt.) Do not use colors and do not extend figures and tables into the margins. Add the number of the pages consecutively, with the numbers placed at the bottom and center of each page.

The full papers processing program and prepared in order of:

**1. Introduction (Times New Roman Bold 12 pt.)**

**2. Material and Methods (Times New Roman Bold 12 pt.)**

**3. Results and Discussion (Times New Roman Bold 12 pt.)**

**4. Conclusion (Times New Roman Bold 12 pt.)**

Text : (Times New Roman 11 pt. normal)

**5. Acknowledgements (Times New Roman Bold 12 pt.)**

Text : (Times New Roman 11 pt. normal)

**References (Times New Roman Bold 12 pt.)**

Cite references in the text by name and year in parentheses.

Some examples: (Smith2013)if at the end of a sentence; Thomson and Walker(2012) if within a sentence; (Smit2013;Thomson and Walker2012; Zeng et al.2009) if several papers are cited simultaneously.

References should be prepared in 11pt.

Times New Roman and to be listed in alphabetical order, as below:

Last Name, First Name initial Middle name initial, Title of the paper, Publication name, **Volume (in bold letters)**, page(s) and the year of publication

Examples:

1. Tancous, J.J., *Skin Hide and Leather Defects*, Leather Industries of America, Lee Corporation, 123,1992.
2. Abrahamson H.B., Lukaski H.C., Synthesis and Characterization of Iron Stearate Compounds, *J. of Inorganic Biochemistry*, **54**, 115-130, 1994.
